Parental/Carer Privacy Notice

Policy Statement

We are Pinchmill Primary School. During your child's time as our school, we will gather and use information relating to you. Information that we hold in relation to individuals is known as their 'personal data'. This will include data that obtain from you directly and data about you that we obtain from other people and organisations. We might also need to continue to hold your personal data for a period of time after your child has left our school. Anything that we do with an individual's personal data is known as 'processing'.

This document sets out what personal data we will hold about you, why we process that data, who we share this information with, and your rights in relation to your personal data processed by us.

What information do we process in relation to you?

We will collect, hold, share and otherwise use the following information about you:

- Personal information (such as name, date of birth, address, health and medical needs, development needs, home and mobile numbers, personal email address, emergency contact details and relationship marital status)
- Financial information such as eligibility for free childcare or free school meals.
- Your relationship to your child, including any court orders that may be in place.

We may also use special categories of data such as gender, age, ethnic group, sex or sexual orientation, religious or similar beliefs. These types of personal data are subject to additional requirements. We will use this data for reporting purposes or to support students within our school.

Where do we get your personal data from?

We will obtain information about you from other sources. This might include information from the local authorities or other professional or bodies, including a Court, which might raise concerns in relation to your child.

Why do we use your personal data?

We will process your personal data for the following reasons:

1. Where we are required by law, including:
 - To provide reports and other information required by law in relation to the performance of your child
 - To raise or address any concerns about safeguarding
 - To the Government agencies including the police
 - To obtain relevant funding for the school
 - To provide or obtain additional services including advice and/or support for your family

2. Where the law otherwise allows us to process the personal data as part of our functions as a School or we are carrying out a task in the public interest, including:
 - To confirm your identity
 - To communicate matters relating to the trust to you
 - To safeguard you, our pupils and other individuals
 - To enable payments to be made by you to the school
 - To ensure the safety of individuals on the School site
 - To aid in the prevention and detection of crime on the school site
 - To enable the education of our pupils
 - To fulfil our duty of care to our pupils

3. Where we otherwise have your consent

Whilst the majority of processing of personal data we hold about you will not require your consent, we will inform you if your consent is required and see that consent before any processing takes place.

Why do we use special category personal data?

We may process special category personal data in relation to you for the following reasons:

1. Where the processing is necessary for reasons of substantial public interest, including for purposes of equality of opportunity and treatment, where this is in accordance with our Data Protection Policy.
2. Where the processing is necessary in order to ensure your health and safety on the school site, including making reasonable adjustments for any disabilities you may have.
3. Where we otherwise have your explicit written consent.

There may also be circumstances where we need to use your information in relation to legal claims, or to protect your vital interests of those of your child, and where it is not possible to see your consent.

Failure to provide this information

If you fail to provide information to us we may be prevented from complying with our legal obligations.

How long will we hold your personal data for?

We will hold your personal data only for as long as necessary. How long we need to hold on to any information will depend on the type of information. Medical records and accident records are kept for longer according to legal requirements.

Who will we share your personal data with?

We routinely share information about you with:

- Local authorities, to assist them in the exercise of their responsibilities in relation to education and training, youth support and safeguarding purposes .
- Local Authority (where you claim up to 30 hours free childcare as applicable)
- Ofsted – during an inspection or following a complaint about our service.
- The school that your child will be attending.

- Have your data transferred to another organisation
